## Technical Requirements

Digital files are required for advertising submissions. Faxed ads will not be accepted. The required format for a print ad is a high-resolution (300 dpi or greater) PDF (Adobe Acrobat 4 or higher distilled for print quality), JPEG, EPS, or TIF. The mode of black-and-white images should be “grayscale,” and color images should be “CMYK”. Laser proofs must be provided for all ads. All ads must conform precisely to these requirements. Ads not conforming to these requirements will not be published.
